

**GRAND RIDGE DISTRICT #95  
BOARD OF EDUCATION MEETING**

**August 9, 2022**

The August regular monthly Grand Ridge School Board of Education meeting was called to order by President Mike Wielgopalan, on Tuesday, August 9, 2022, at 7:15pm. Answering present were: Mary Domoleczny, Kate Jaegle, John Lubelski, George Lukach, Kayla Simons and Mike Wielgopalan. Also present were Ted Sanders, Terry Ahearn and Judy Wilkinson. Rich Frye was not in attendance.

Visitor to the meeting was Paula Krohe.

After the Pledge of Allegiance, a motion to approve the minutes of the July 12 meeting was made by George Lukach. This was seconded by John Lubelski. A voice vote was taken: All ayes. Motion passed.

The Treasurer's report was read and approved, to be placed on file for further audit with a motion made by John Lubelski and seconded by Mary Domoleczny. A voice vote was taken: All ayes. Motion carried.

**Payment of Bills:** The bills for the month of July were inspected and presented for payment. A motion was made to approve the bills by John Lubelski. This was seconded by George Lukach. A roll call vote was taken: All ayes. Motion carried.

**Safety Hazard Bus Route-**Kayla Simons made a motion to approve the safety hazard bus route. Mary Domoleczny seconded the motion. A voice vote was taken: All ayes. Motion approved.

**Superintendent's Report:** Mr. Sanders reported on the following items:

- Enrollment Information: We currently have approximately 186 students.
- Building updates: All classrooms are being set up. For the air conditioning project we are waiting on a few head units, a couple of condensers and the electrical panels. Keyless doors were discussed.
- Milk bid: The milk bid from Prairie Farms was discussed. Kate Jaegle motioned to accept the firm bid of .3640/8 oz. carton of 1% white milk, .3420/8 oz. carton of skim white milk and .3860/ 8 oz. carton of FF chocolate milk. This was seconded by Kayla Simons. A voice vote was taken: All ayes. Motion carried.
- Triple I Conference: Ted needs all board members to notify him of who will be attending.

**Executive Session** - A motion was made by John Lubelski to move to closed session. This was seconded by Mary Domoleczny. A voice vote was taken: All aye. Motion carried. The board went into executive session at 8:53p.m.

A motion to return to open session was made by Mary Domoleczny. This was seconded by Kayla Simons. A voice vote was taken: All ayes. Motion carried.

position. John Lubeski seconded the motion. A voice vote was taken: All Ayes. Motion carried.


A motion was made by Kate Jaegle to accept the resignation of Ted Sanders as half time Athletic Director. John Lubeski seconded the motion. A voice vote was taken: All Ayes. Motion carried.






The next regular meeting of the Grand Ridge School Board of Education will be held on Tuesday, September 13, at 7:00p.m.
