

**GRAND RIDGE DISTRICT. #95
BOARD OF EDUCATION MEETING**

October 12, 2021

The October regular monthly Grand Ridge School Board of Education meeting was called to order in regular session by President Michael Wielgopalan, on Tuesday, October 12, 2021 at 7:06 p.m. Roll call was taken. - A discussion was held on the Levy for 2022. It was agreed that the Finance Committee would meet to review this and make a recommendation to the Board.


